Guidelines for Show

Exhibition Dates:

September 12- October 29, 2010

Exhibit Location:

The Victor R. Small House
Sampson Arts Council
709 College Street, Clinton, NC

Eligibility:

Any artist (18+ years old) is invited to enter art in the following categories:

Acrylic, Digital Art, Drawing/Pastel, Mixed Media, Oil, Photography, & Watercolor.

Requirements for Entries:

Participants may submit a maximum of two (2) entries, which must be completely original by the artist, created after January 1, 2008, remain on display for the duration of the exhibit and not previously entered in the Swine Show. Due to limited space, art must not exceed 48" (including frame) in any dimension or weigh more than 50 lbs. All work must be complete, dry, framed (if needed), prepared for hanging with wire-saw tooth hangers and clip frames will not be accepted. Art requiring special installation cannot be accepted. SAC has the right of final decision on installation. All art selected for the show will be exhibited, unless SAC exercises its right to withdraw any art that it considers unsuitable for public display.

Delivery Dates may be after August 31st until September 10th

The Gallery is open Tuesday-Friday from 10 am until 2 pm, and 4 -7 pm.

Entry Fees:

One Entry: \$20
Two Entries: \$25

Juried Show Judge:

Rebecca Scott Reynolds

Gallery Director and Children's Art Education Director of the Arts Council of Wayne County. Mrs. Reynolds is also a professional photography and owner of RSR Photography and Fine Art.

Awards:

The following awards and ribbons are presented at the discretion of the judge:

Best in Show.....\$250
Best in Sampson County.....\$150
People's Choice.....\$100
Honorable Mention.....Ribbon

Art Sales and Pricing:

SAC prefers all art be for sale. A \$15 fee will be charged for each entry that is not for sale. To assist you with pricing, art priced between \$250-\$900 has a better chance of selling. Prices may not change once the exhibit opens. SAC retains a 30% commission on all sales.

Art Removal:

Art must remain on exhibit until October 29th. Due to lack of storage, removal of entries may begin October 29, 10 am to 5pm, but must be picked up by 5pm on November 5, 2010.

Liability:

All reasonable care will be given in the handling and display of the art, and all art exhibited is insured from time of delivery until 5pm on November 5. SAC staff, representatives and or sponsors assume no responsibility for the loss of or damage to art.

Rights & Conditions:

The artists grants SAC permission to photograph and reproduce any art for publicity and

educational purposes. SAC reserves the right to refuse, remove, ore reject any art. Entry of art constitutes agreement with conditions described herein.
